



CONTEST RULES AND REGULATIONS
RCN + SNY 2014 SPRING TRAINING SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER

OPEN ONLY TO LEGAL RESIDENTS WHO ARE RCN SUBSCRIBERS IN RCN'S SERVICE DELIVERY AREAS LOCATED IN AND AROUND WASHINGTON, DC, CHICAGO, IL, BOSTON, MA, NEW YORK, NY, AND PHILADELPHIA, PA, 18 YEARS OF AGE OR OLDER

1. **PARTICIPATION:** By completing the entry form to the SPRING TRAINING SWEEPSTAKES and providing your valid contact information for the RCN + SNY 2014 SPRING TRAINING SWEEPSTAKES ("SPRING TRAINING SWEEPSTAKES"), you are officially entered to this SPRING TRAINING SWEEPSTAKES and you agree to be bound by the following rules ("Official Rules"), which constitute a binding agreement between you, on one hand, and Sponsors on the other. Winners will be announced via RCN's Social Media networks, including Facebook and Twitter, on the next business day after submissions end.

By entering the SPRING TRAINING SWEEPSTAKES, all qualified submissions become eligible to win the GRAND PRIZE. One (1) GRAND PRIZE Winner will be randomly selected at RCN's sole discretion among qualified submissions. The GRAND PRIZE Winner will be announced via RCN's Social Media networks, including Facebook and Twitter, on February 19, 2014.
